

To listen to the audio transcript:

A)

Download FTR (For The Record) Player. This is very easy to do. You just go to the FTR website at [Download FTR Player for free \(Windows only\) \(fortherecord.com\)](http://fortherecord.com). Click on the Download button on the right. An ADD TO CART page will appear. Just check out as you would on any online ordering website. The player is free. After you check out, a login page will appear. Click on 'create account' beneath the SIGN IN button. You will be asked for your first and last name, email address and to choose a password. Once created, a page will appear with a 'Download the free FTR player' option. Click on this and just follow the directions (you will have to repeat the ADD TO CART step one more time).

B)

The audio transcript can be difficult to hear as the Irish High Court acoustics/sound system is not the best. In order to better hear the audio, you can enhance it by downloading (free) DFX Audio Enhancer at [DFX Audio Enhancer – Boost Your Sound \(fxsound.com\)](http://fxsound.com). Click on Download DFX. Then open the file and follow the set-up procedure for installation. Perhaps you won't need this enhancer if you have a better PC than I or other types of enhancers/audio accessories.

C)

The audio of my hearing is broken into five-minute segments. When you open an audio file (one of these five-minute segments below, an FTR player (Playback Panel) will appear. When using the player, there are six volume/sound settings on the right. I suggest placing the first five settings at high and keeping the sixth setting on the very right at zero (i.e., halfway) otherwise you get some weird sound effects.

While I have played the audio transcript alongside the written version, and the written version seems to have been accurately transcribed from the audio, I still ask those of you doing the same to be cognizant of any possible mischaracterizations in error and to let me know if you find any.

Click on Audio file 1 below to start the first five-minute recording segment of my High Court hearing.

Note – My presentation (Maurice Landers – Plaintiff) runs from Audio files 1 through 14. The Information Commissioner’s presentation (David Browne BL – Respondent) runs from Audio files 15 – 22. My rebuttal is then presented in the remaining Audio files 22 (second half) through 26.
